The administrative approval system reform

On 22nd August, 2012, after the executive meeting of the State Council which was presided over by PM Wen Jiabao, China released a statement to remove and modify 314 administrative examination and approval items in order to reform the administrative approval system. Guangdong Province was chosen as the first pilot region of the reform during the 12th Five-Year Plan period (2011-2015) after this statement release.

According to the statement, in the 314 modified items, 184 items will be cancelled, the power to approve 117 items will be handed down to government departments at lower levels, and 13 items will be combined with other items. This reform will mainly focus on the fields of investment and social projects, especially on real economy, small and micro-sized enterprises and private investments.

The administrative approval system reform of China started since 2001 and had been modified five times in the last ten years. As to date, the State Council had moved and modified 2497 administrative approval items in total, which represents 69.3% of total original items. Guangdong province had justified administrative approval system for four times respectively in 2000, 2002, 2004 and 2009, which totally cut and modified 2300 administrative approval and examination items.

The list below shows examples of administrative approval system reform by People's Government of Guangdong Province in 2012. These examples are included in the first round of this reform with total 354 amended items. In the future, Guangdong Province will release more amendments on administrative approval system reform.
